TSMDC Ltd., has entered into an agreement with M/s. Harsha Constructions Pvt Ltd., on 14.08.2022 for a period of Six (6) Months w.e.f. 14.02.2022 to 13.08.2022 for the quantity of 471820 CBM.

Further, considering the request of M/s. Harsha Constructions Pvt Ltd., is extending the agreement of Palugula-6 Palugula & Maddulapally Village of Mahadevpur Mandal, Jayashankar Bhupalpally District for another One(1) Year i.e., from 14.08.2022 to 13.08.2023, for a balance quantity 451994.75 CBM of sand i.e., 3,26,994.75 Cum/5,23,191.6 MT from Palgula-6 & allotting 1,25,000 CBM (2,00,000 MT) from Pusukupalli-2 in lieu of Palugula-6 sand reach.

Further it is to inform that the following below clause is applicable along with same terms and conditions entered into the contract Agreement on 14.08.2020 shall continue during this extension period of Agreement.

"The Contractor shall not be entitled to claim interest on EMD. Further 7 1/2 % of the bill amount will be deducted from running bills towards Security Deposit and after successful completion of the contract the 5% will be paid to contractor along with final payment and remaining 2 1/2 along with EMD will be paid after successful hand over of the stockyard in original shape".
